

Car Rental conditions 2023 Auto-Mischner Gründelweg 12 01814 Bad Schandau

- The hirer assumes a roadworthy, operational and fully fueled vehicle.
- If the vehicle is not refueled on return, we will charge fuel according to the receipt and an administration fee of € 10. Please refuel with suitable fuel, i.e. no E 10 or bio-diesel.
- Smoking and transport of animals in the car are not allowed, otherwise there is a cleaning fee of 50€.
- The vehicle may only be used by the drivers named in the rental contract and not sublet. The renter must be in possession of a valid driver license.
- The vehicle is to be returned to the agreed place on the agreed date. The hirer must handle the vehicle carefully and in accordance with the operating instructions. For a rental period of more than 2 weeks please check oil, water and tire pressure.
- The transport of hazardous substances or goods is prohibited; the use is in accordance with Highway Code. The hirer is not permitted to use the vehicle outside of public roads or in commercial passenger or freight traffic, to participate in off-road driving or motorsport events.
- International trips are to be reported to Auto-Mischner. Any cashing or fines plus an administration fee of 10€ are to be borne by the renter
- The calculation of the rental period is day = 24 hrs. The rental price is based on the rental price lists, dated 01.01.2023. A deposit in cash up to 500 €, or in the amount of the expected rental fee, is at the discretion of Auto-Mischner.
- We accept cash, EC card, VISA, MAESTRO card (AMEX is only accepted for a fee of 10€)
- Theft, accident, fire, wild or burglary damage have to be reported immediately to the police (emergency number 110) with accident report and to the Auto-Mischner. The renter must ensure that the scene of the accident is not changed. The data of all participants must be recorded. Enemy claims must not be recognized by anyone.
- If a repair is necessary during the rental period to restore the viability or safety of the vehicle, repair orders may only be issued with the consent of Auto-Mischner. The repair must be carried out by a Ford-certified service-partner, provided that this is possible and reasonable in the individual case. The costs of repair are borne by Auto-Mischner, as far as the tenant presents the appropriate documents and is not liable according to the rental conditions.
- **Insurance details:**
 - Vehicle liability insurance with unlimited coverage
 - Fully comprehensive insurance excess 1000€ or partial
 - Liability reduction is possible at extra costs, pls. see rental price list
 - Driver, passengers, luggage, goods etc. are not insured additionally
- The renter is liable for accidental damage caused by him, for the rep. Costs or for a total loss to the replacement value less residual value, limited to the maximum amount specified in the current price list, unless a substitute can be obtained by insurance.
- Notwithstanding the above provision, the hirer is fully liable for all damage caused by intent and gross negligence, in particular in the case of drug or alcohol-related unfitness for driving or in the event of damage due to non-compliance with the permissible headroom (§41 Abs.2 Ziff.6, 265 StVO). or overload of the vehicle. The same applies to damage caused by use of the vehicle for unlawful purposes, use by unauthorized third parties, by cargo, improper treatment o. Use of the vehicle for prohibited purposes and such, as a result of breaches of obligations of the renter on the behavior at the scene of the accident.
- Place of fulfillment for all claims arising from this contract is the registered office of the lessor, court of jurisdiction District Court Pirna
- By the announcement of my personal data on the lease I agree that these are collected, recorded and stored until further notice.
